Four-year-old Kindergarten (4K) is a half-day program (2.5 hours) available to all children in the School District of Holmen who turn four years old by September 1 of the year they enroll. 4K is a one-year program, which children attend the year prior to starting Kindergarten. We do not have early entrance into 4K.

There are four elementary schools in the School District of Holmen: Evergreen, Prairie View, Sand Lake, and Viking. Starting in the fall of 2025, each elementary school will have at least one session of 4K in the AM (8:30 – 11:00 am), PM (1:00 – 3:30 p.m.), or both. The District determines which of the four schools is the student's "home school" based upon your residential address. While our goal is to have all students attend their "home school," we do realize that many of our 4K students will need childcare services at an address within district boundaries that is different from your residence (i.e. daycare center, in-home care provider, extended family, friend, etc.). In those cases, the district may assign your child to attend 4K at the school in the boundary where the pick-up and drop-off address is located. Please note that we do not provide transportation to care providers outside of our district boundaries.

If you are a resident of Holmen, you are encouraged to begin the enrollment process on February 3, 2025 for the upcoming school year through the [School District of Holmen](#) webpage. Click on the "ENROLL A STUDENT" tab along the right side of the page. All enrollment is done online. If you need access to a computer, please stop by the Frederic D. Frick Administrative Center, located at 1019 McHugh Road.

You will need the following items ready for when you enroll:

- Verification of Residency, examples include: Driver's license or state issued photo ID, Utility bill (gas, electric, cable, internet), Lease or Rental agreement, or Property Tax Bill
- Immunization Records of child being enrolled
- Birth Certificate of child being enrolled

If you are not a resident of Holmen, Wisconsin's interdistrict public school Open Enrollment program allows parents to apply for their children to attend school districts other than the one in which they live. Applications may be submitted to no more than three non-resident school districts. Students in 4K through grade 12 may apply to participate in Open Enrollment. Parents should call their resident school districts to find out if their preschool-aged children qualify for Open Enrollment. The Open Enrollment application period for the 2025-26 school year is from February 3 - April 30, 2025 until 4:00 p.m. Parents must apply to the non-resident district. A non-resident district is defined as the district in which you do not live, but where you want your child to attend. It is recommended that you apply for Open Enrollment through the on-line application process at <http://dpi.wi.gov/oe>. The Open Enrollment application period closes at 4:00 p.m. on April 30, 2025. Late applications will not be accepted for any reason.
